- 1.2 Our services include the installation of chatbots on customers' websites, providing account login to view chat data, and using ChatGPT.

- 2.2 We do not collect real names; however, we collect email addresses for account registration and mobile phone numbers when users enable two-factor authentication ("2FA").
- 2.3 You are responsible for maintaining the confidentiality of your Account Password and are fully responsible for all activities that occur under your account. You agree to notify us immediately of any unauthorized use of your account or any other breach of security.
- 2.4 You may enable 2FA for additional security, which requires storing your mobile phone number.

#### 3. Use of Services

- 3.1 You agree to use the services only for lawful purposes and in a way that does not infringe the rights of, restrict, or inhibit anyone else's use and enjoyment of the services.
- 3.2 The AI we install is capable of booking appointments or callbacks on your behalf.

#### 4. Data Collection and Privacy

4.1 We collect and store email addresses and, if applicable, mobile phone numbers for 2FA. We do not collect real names.



- 4.2 Account holders can access that data and other account-related information by logging into their account.
- 4.3 Users can delete their account and all associated personal data at any time by logging into their account and selecting the "Delete Account and Data" button.
- 4.4 Our collection, use, and storage of your data are governed by our Privacy Policy, which is incorporated by reference into these Terms of Service.

#### 5. Termination and Deletion of Accounts

- 5.1 You may terminate your account at any time through your account settings by selecting the "Delete Account and Data" button. Upon termination, all your personal data will be permanently deleted from our systems.
- 5.2 We reserve the right to suspend or terminate your account and access to the services at our discretion, without notice, for conduct that we believe violates these Terms of Service or is harmful to other users of the services, us, or third parties, or for any other reason.
